A HEART FOR JUSTICE: MEET ROBBIE PFEIFFER

From the football fields of Carrollton to the courtrooms of Dallas, Robbie Pfeiffer's story is all about grit, growth, and gratitude. A true Texan through and through, Robbie has never been one to shy away from hard work—or a good challenge. "I've had a job since I was 15," he says with a laugh. "I've done everything from cleaning golf carts and bartending to operating a forklift." Each experience, he explains, taught him something about people—and about perseverance.

After high school, Robbie pursued his dream of playing college football at the University of North Texas, where he learned the value of discipline and teamwork both on and off the field. When his athletic journey came to an end, he shifted his focus toward academics, spending time at a local community college before transferring to Portland State University, and later returning home to complete his degree at the University of Texas at Dallas. His academic drive ultimately led him to Pepperdine University School of Law, where he earned his law degree —a milestone made even more meaningful when his daughter, Olivia, was born the summer after his first year. "That moment changed everything," Robbie shares.

It reminded me that every goal is worth the grind when you're doing it for something bigger than yourself."

Robbie's legal career began in family law—but it didn't take long for him to find his true calling

"I spent a year in family law and quickly realized it wasn't for me," he admits. "But when I joined the Dallas County District Attorney's Office, everything clicked." What started as a plan to gain a few years of trial experience turned into an 18½-year career, during which he prosecuted countless cases—from assaults and intoxication-related offenses to capital murders. "It was demanding, but deeply rewarding work," he says. "Every case mattered because every victim mattered."

Now, Robbie brings that same dedication and compassion to his work at Snellings Injury Law.

"From my first vibe check with the team, I knew this was where I wanted to be," he says. "Everyone here—from our attorneys to our support staff—cares deeply about doing right by people. That's rare, and it's something I'm proud to be part of." When he's not advocating for clients, you'll likely find Robbie on the golf course (where the feeling isn't always mutual, he jokes), on a mountain road trip, or cheering on his Dallas teams the Cowboys, Mavericks, Stars,

20-MINUTE CHICKEN & VEGGIE STIR-FRY

Ingredients (serves 4):

- 2 cups cooked chicken (rotisserie or leftover works great)
- 2 cups mixed vegetables (fresh or frozen)
- 2 tbsp soy sauce
- 1 tbsp olive oil or sesame oil
- 1 clove garlic, minced
- 1 cup cooked rice or quinoa (optional)

Instructions:

- 1. Heat oil in a large skillet over medium heat.
- 2. Add garlic and vegetables; sauté for 3–4 minutes.
- 3. Stir in chicken and soy sauce, and cook until heated through.
- 4. Serve alone or over rice for a complete meal.



Tip: Add a drizzle of honey or teriyaki sauce for extra flavor and it's still under 20 minutes total.

Answer: B - Always document the scene and contact authorities. Photos and reports protect you later if injuries or damage appear.

Our message is simple: plan ahead, drive responsibly, and arrive safely."



This season, the best gift you can give your loved ones is arriving home safely.


