ONE-PAN GARLIC BUTTER SAUSAGE & VEGGIE SKILLET

Ingredients (serves 4):


- 1 lb. smoked sausage, sliced
- 2 tbsp butter
- 1 tbsp olive oil
- 3 cloves garlic, minced
- 2 cups broccoli florets
- 1 bell pepper, sliced
- 1 zucchini, sliced
- 1 cup cherry tomatoes
- 1 tsp Italian seasoning
- Salt and pepper to taste

Instructions:

1. Heat olive oil in a large skillet over medium heat. Add sausage and cook for 4 to 5 minutes until browned. Remove sausage and set aside.
2. In the same skillet, add butter and garlic. Stir for about 30 seconds until fragrant.
3. Add broccoli, bell pepper, and zucchini. Season with Italian seasoning, salt, and pepper. Cook for 6 to 8 minutes, stirring occasionally, until vegetables are tender but still crisp.
4. Add cherry tomatoes and cook for 2 more minutes.
5. Return sausage to the skillet, stir everything together, and heat through for 1 to 2 minutes.



Optional: Top with Parmesan cheese, and feel free to add any other vegetables you have on hand.
